**SUBJECT:** 2017 Child Care and Child and Family Program  
Allocations and Service Agreement Package

---

We are pleased to provide the 2017 child care allocations for Consolidated Municipal Service Managers (CMSMs) and District Social Services Administration Boards (DSSABs).

On September 12, 2016, the government made a historic commitment in announcing a major Child Care Expansion Plan ("Expansion Plan"). This plan will create access to licensed child care for 100,000 more children aged 0-4 years old over the next five years. To support this commitment, the government is making a historic investment of \$170 million in the current fiscal year, resulting in a total investment of \$1.37 billion including wage enhancement in 2017. The investment for the expansion plan will grow to \$200M next year.

In the first year of this expansion plan, this substantial new funding for licensed child care will support approximately 16,000 more children 0-4 years old. This funding will support new child care fee subsidies, expand access to affordable licensed child care spaces and reduce fee subsidy waitlists to help parents access quality child care.

The ministry has maintained an equitable and transparent approach for allocating the child care expansion investment to CMSMs and DSSABs. Funding has been allocated through modifying the current child care funding formula (CCFF) weighting the calculation to use the 0-3.8 age data measures only excluding capping and utilization. The new investments do not require municipal cost sharing and the ministry has permitted up to 10% of the allocation to be used towards administration for the expansion plan. Please refer to appendix A for your 2017 allocations.

In addition to this historic investment for the expansion plan, the province continues to work with the Federal government on the Early Learning and Child Care Framework (ELCC). As you know, the 2016 Federal Budget committed \$500M in 2017-18 to support the establishment of an ELCC, including \$100M for Indigenous child care and early learning on-reserve. On March 22, the 2017 Federal Budget committed an additional \$7 billion over 10 years, starting in 2018-19, to support and create more high-quality, affordable child care spaces across the country. More information will be shared as it becomes available.

### Confidentiality and Public Announcements

Announcements regarding additional children and families served through these investments are communications opportunities for the provincial government and CMSMs, and DSSABs. Therefore, CMSMs and DSSABs announcements related to funding received through the provincial child care expansion plan **must** clearly acknowledge that the contributions were made by the Province of Ontario. In addition, any such communications opportunities should remain confidential until they are announced publicly by the Province of Ontario or jointly by the provincial government, CMSMs and DSSABs.

The intent is to help promote the role of the Ministry of Education, CMSMs and DSSABs, and community partners in bringing new investments to local communities. For more information on the announcement protocol, please refer to appendix B.

## **Enhanced Accountability Requirements**

### **A. Enveloping**

Funding for the expansion plan is an enveloped allocation and can only be spent on incremental expenditures (i.e. additional expenditures above the previous year's expenditures) for children aged 0-4 years old excluding children eligible to attend junior kindergarten. Any funding not spent on the prescribed expenditures will be recovered by the ministry. To support the success of this commitment and to allow for sufficient local planning, the ministry is providing CMSMs and DSSABs with the ability to use funding for this commitment and meet expansion targets up to **December 31st, 2018**. Through enhanced financial reporting requirements, CMSMs and DSSABs will demonstrate how this funding is used to increase the number of children served in their region.

## **B. Addressing local needs**

Expansion plan funding must be spent on the following priorities focused on increasing access to affordable child care for children aged 0-4 years old, excluding children eligible to attend junior kindergarten:

1. To support additional fee subsidies; and/or
2. Increased access

If these two priorities cannot be met due to local considerations, service system managers may use this funding to meet their expansion targets by broadly reducing licensed child care fees and increasing affordability for children aged 0-4 years old. The ministry's expectation is that service system managers demonstrate they have attempted to meet the two priorities before exploring this option.

## **C. Expansion Targets**

The ministry will provide each CMSM and DSSAB with an estimated expansion target for 2017-18 in their 2017 service agreement. As the expansion plan is a fiscal year investment, the ministry is providing for information purposes, allocations for the first quarter of 2018 to support local planning (please refer to appendix A). EDU child care advisors will work with service system managers to confirm and submit the expansion targets in signed service agreements returned to the ministry.

The ministry will support CMSMs and DSSABs throughout 2017 and 2018 to meet the confirmed targets, however should expansion targets not be met by 10% or more, and 10 children or more in the aggregate by December 31<sup>st</sup>, 2018, cash flow for the expansion plan will be reduced by 1 per cent to reflect the underachievement of the targets.

## **D. Prioritizing Not for Profit Operators**

The ministry is taking steps to further prioritize provincial funding to the not-for-profit child care sector. Beginning in 2017, a "For Profit Auspice Threshold" has been added in service agreements to support CMSMs and DSSABs with maintaining funding to for-profit entities at or below previous years expenditure levels. This threshold applies to both base child care funding and the new investments for the expansion plan. The ministry recognizes that a number of communities in Ontario are served by for-profit child care operators to support access to child care for children and families. The ministry will work with CMSMs and DSSABs through this transition to meet the thresholds.

## **UPDATES**

### **E. Child Care Funding Formula**

As part of our annual process, the ministry has updated the 2017 child care funding formula with revised data elements including:

- Increases to benchmarks to reflect new investments.
- Refreshed Ministry of Finance's population projections and Low Income Cut-Off (LICO). Changes to LICO data (2006 to 2011 data) will continue to be phased in over a 4 year period from 2015-2018.
- The integration of Full Day Kindergarten (FDK) Transition and Transformation (approximately \$54.5 million) across the child care funding formula to reflect the full implementation of FDK, as signaled in 2016 in memo EYCC17.
- Capital retrofit allocation has been removed from the child care funding formula and framework as 2016 was the final year for this allocation.

### **F. Wage Enhancement**

An ongoing commitment supports a wage increase for child care professionals employed in the licensed child care sector through the wage enhancement and Home Child care Enhancement Grant (HCCEG). Details on the 2017 implementation approach were provided in the EYCC11 memo circulated on December 15, 2016. Funding for the wage enhancement/HCCEG has continued to flow based on 2016 entitlement (as reported in 2016 Estimates submissions). 2017 Cash flow will be adjusted once funding entitlements are submitted to the ministry through the Revised Estimates submission, which are due on **August 31, 2017**.

### **G. Data Analysis Services**

Funding for data analysis services will be included in your 2017 child care and child and family programs service agreement, and will begin to flow once signed agreements are received by the ministry.

## **2017 REPORTING REQUIREMENTS**

### **2017 Estimates**

Due to the timing for the release of 2017 allocations and service agreements, the ministry will not require the submission of Estimate Reporting for 2017. CMSMs and DSSABs are required to submit 2017 Revised Estimates submissions by **August 31, 2017** in EFIS 2.0. Further information about this submission will be available in the coming months.

## **Contractual Service Targets**

Consistent with 2016, the ministry requires CMSMs and DSSABs to set contractual service targets for fee subsidy, Ontario Works and special needs resourcing. These targets are for base child care funding only. New this year is the requirement for expansion targets as indicated above. Child Care Advisors will be coordinating meetings with CMSMs and DSSABs in the coming weeks to discuss the service and expansion targets for 2017.

## **Cash Flow in 2017**

Monthly cash flow for operating funding will continue to be based on the 2016 Revised Estimates submission entitlement until the 2017 signed service agreement is received.

Monthly cash flow will be updated to reflect your 2017 allocation, including funding in support of the expansion plan, once the signed 2017 service agreement is received by the ministry.

As in previous years, in areas designated under the *French Language Services Act* (FLSA), CMSMs and DSSABs must meet the FLSA requirements outlined in their service agreement. Where the CMSM or DSSAB is not at full capacity, it is required to submit a plan to the ministry to build capacity. The 2017 plans are due to the ministry by **June 30, 2017**.

## **Appendix B: Communications Protocol Requirements: Ontario's Child Care Expansion Plan**

All public announcements regarding provincial investments in Ontario's child care and early years system are potential joint communication opportunities for the provincial government, school boards, the Consolidated Municipal Service Manager/District Social Services Administration Board (CMSM and DSSAB), municipalities and community partners.

### ***Public Communications***

Municipalities, school boards, CMSMs and DSSABs, and community partners should not issue a news release or any other public communication directed at media regarding major child care and early years investments, without publicly recognizing the Ministry of Education's role of providing funding.

The Ministry of Education may also choose to issue its own news release and/or hold events about investments in child care and early years projects, in addition to those prepared by municipalities, school boards, CMSMs and DSSABs, and community partners.

The intent of this protocol is to promote the role of both the Ministry of Education and stakeholders in bringing new child care and early years projects to local communities.

### ***Major Announcements and Events***

**Important:** For all major child care investments the Minister Responsible for Early Years and Child Care must be invited as early as possible to the event. Invitations can be sent to [EYCCinvestments@ontario.ca](mailto:EYCCinvestments@ontario.ca), with a copy sent to your ministry child care advisor. Municipalities, school boards, CMSMs/DSSABs, and community partners are not to proceed with their public event until they have received a response from the Minister's Office regarding the Minister's attendance. Municipalities, school boards, CMSMs/DSSABs, and community partners will be notified at least four to six weeks in advance of their opening event as to the Minister's attendance. Please note that if the date of your event changes at any time after the Minister has received the invitation, please confirm the change at the email address above.

If the Minister Responsible for Early Years and Child Care is unavailable, the invitation may be shared with a government representative who will contact your municipality, school board, CMSM and DSSAB, and community partner to coordinate the details (e.g. joint announcement). Municipalities, school boards, CMSMs/DSSABs, and community partners are not expected to delay their announcements to accommodate the Minister or a Member of Provincial Parliament (MPP); the primary goal is to make sure that the Minister is aware of the announcement opportunity.

## ***Other Events***

For all other media-focussed public communications opportunities, such as sod turnings for example, an invitation to your local event must be sent to the Minister Responsible for Early Years and Child Care by email with at least three weeks' notice. Again, please send a copy to your ministry child care advisor. Please note that if the date of your event changes at any time after the Minister has received the invitation, please confirm the change at the email address above.

Municipalities, school boards, CMSMs and DSSABs, and community partners are not expected to delay these "other" events to accommodate the Minister. Only an invitation needs to be sent, a response is not mandatory to proceed.

This communications protocol does not replace our stakeholders' existing partnerships with the Ministry of Education's. Regional child care advisors and regional child care licensing staff should still be regarded as primary points of contact for events and should be given updates in accordance to existing processes.

## ***Acknowledgement of Support***

The support of the Government of Ontario must be acknowledged in media-focused communications of any kind, written or oral, relating to the expansion plan. This acknowledgment could include but is not limited to, any report, announcement, speech, advertisement, publicity, promotional material, brochure, audio-visual material, web communications or any other public communications. For minor interactions on social media, or within social media such as Twitter, Vine, etc. where there is a tight restriction on content, municipalities, school boards, CMSMs and DSSABs, and community partners are not required to include government acknowledgement. In addition, when engaged in reactive communications (e.g., media calls) municipalities, school boards, CMSMs and DSSABs, and community partners do not have to acknowledge government funding; however, if possible, such an acknowledgement is appreciated.
